### ABSTRACT

This document presents the guideline for the preparation of the manuscript for the proceedings of the DET2008 conference. For consistent formatting the authors can type over the contents of this document or follow the instruction. For authors' details, use the central format above for single author, and delete the rest, use double authors' name in case of two authors and delete the rest and so on. Please note that this abstract should be kept rather short, no more than 150 words. Its purpose is to give a very general overview of the contents of the paper, without replacing the "introduction", and to allow easy indexing in the bibliographic database. The minimum and maximum number of pages for the final manuscript are 8 and 10 pages, respectively. The final manuscript is to be received in both MS Word and in Adobe PDF versions.

### 1. FIRST MAIN TITLE LEVEL ONE

For the first heading of the first section and after each figure and table please use "**DET\_1st Title Level One**" style from the formatting options of this template. The first heading is capitalised, with Arial font in 12pt, Bold, single line spacing, justified.

The first paragraph of each numbered section is formatted with style "**DET\_first Paragraph Main Text**", which is in Times New Roman font, 11pt, justified, with no indentation and single spacing.

For the subsequent paragraphs use style "**DET\_Other Paragraphs Texts**", which is similar to the first paragraph but with 4pt indentation on the first line.

### 2. SECOND MAIN TITLE LEVEL ONE

Figures' quality is of the utmost importance for reproduction and clarity. Ensure they are clear, legible, of proper size, etc. Also, for tabular data that

can be typed, please consider these as tables as the figures are illustrations.

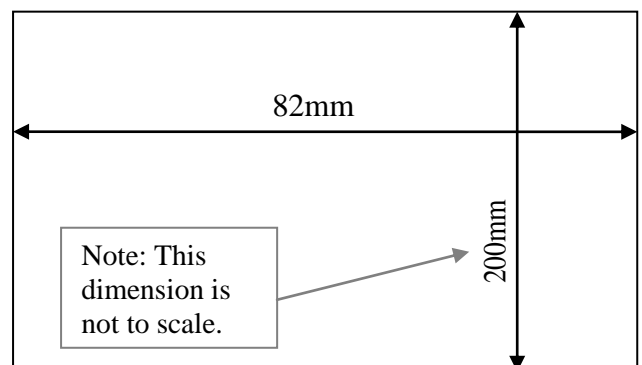


Figure 1 – Maximum dimensions for figures in single column

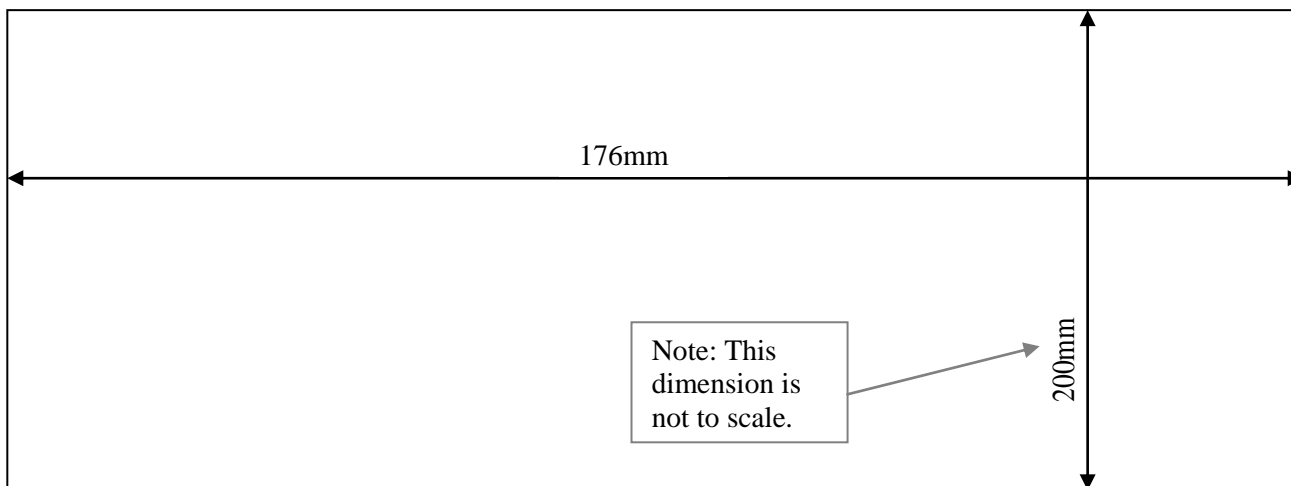
All figures and tables should be placed centred. Figures and tables are preferred to be placed into single column. The maximum size of figures and tables is given in Figure-1. For the figures' caption

please use style “**DET\_Figure Caption**”, which is in Times New Roman font, with 9pt font size, centred with single spacing, 6pt space before and 18pt space after paragraph.

The referencing of figures in the body text should follow this format → Figure-1 and for tables should follow this format → Table-1. A clear line space should be placed after the last paragraph and before the figure, and equations. To avoid the indentation

from left please use “**DET\_1st paragraph Main Text**” for the figure area only.

If it is quite necessary the figures and tables can be placed across two columns. In this case the maximum width for table and figures should not exceed 176mm. An example of dual column figure is shown in Figure-2. For wide figure and tables two section breaks are required, one to change the double column to single, and one to change back from single column to double column.



**Figure 2 – Maximum dimensions for wider (double column) tables and figure**

The caption for figures should be placed in the centre and below the figures and for the tables in the centre and above the tables.

**2.1. FIRST SUBTITLE LEVEL TWO**

Here an example of table is given. Please use the desired format manually for text in tables. For the table caption use style “**DET\_Table Caption**”, which is in Times New Roman font, with 9pt font size, centred with single spacing, 18pt space before and 6pt space after paragraph.

**Table 1- the Caption should be placed above the table**

<b>Column and/or row title can be done in bold</b>	<b>Text in table should be with full characters</b>
Font size should be 9 or bigger	Text is preferred to be cantered

**2.2. SECOND SUBTITLE LEVEL TWO**

The numbering for the subtitles should follow in the right numbering order.

The headings should be kept not more than three levels, but the number of titles can be as many as required within each level.

**2.2.1. First Subtitle Level Three**

This is an example of a title in level three.

**2.2.2. Second Subtitle Level Three**

This is another example of a title in level three. Please note that the heading for level one and two are capitalized for all letter, but for level three only the first letter of each word is capitalized.

**2.3. THIRD SUBTITLE LEVEL TWO**

The equations should have only a caption of number in parentheses. An example is given in equation-1. The referencing of equation in text should follow this format → equation-1.

$$\alpha + \beta = S_i \quad (1)$$

The equation caption should be placed on the right hand side or below the equation if more space is required.

**3. CITATION AND COPYRIGHT**

Depending on the sentence, the authors should kindly refer to references in the following format within the body of the text (ElMaraghy, 2005) or

ElMaraghy (2005). For references with two authors this format should be used (James and Eriksson, 2006), or James and Eriksson (2006) depending on the sentence. For references with more than two authors, the following format should be used (Browns et al, 2007) or Browns et al (2007) depending on the sentence.

The signed copyright transfer form should be submitted with the accepted manuscripts. The form will be available on the conference website.

The list of cited references should be placed in the end.

The reference list should be alphabetically ordered based on the first author's last name. The reference list text should be based on DET

Authors should use style “**DET Reference Text**” for the reference font, which is in Times New Romans font, with font size 10pt, single line spacing with hanging indentation of 0.4cm, with no space before and 6pt space after.
